

**PARENT/LEGAL GUARDIAN CONSENT FORM (Sweden)**  
**(“Consent”)**

Blizzard Entertainment, Inc., a Delaware corporation and a subsidiary of Vivendi Universal Games International, S.A. (“Blizzard”) and Xfire, Inc., a Delaware corporation and a subsidiary of MTV Networks, a division of Viacom International Inc. (“Xfire”) are the sponsors (individually and collectively, the “Sponsors”) of the “World of Warcraft Summer Movie Promotion” (referred to as the “Promotion”) which, among others, is open to qualified legal residents of Sweden (which, for purposes of this Consent will be referred to as the “Territory”).

The Official Rules for the Promotion provide that in order to enter or participate in the Promotion or win and be awarded any prize, a legal resident of the Territory who is at least 13 years old, but is still a minor and not yet considered an adult for purposes of giving consent and entering into contracts (your child, the “Minor”), must obtain the written consent of their parent or legal guardian (a “Parent”) and submit it with their entry.

This Consent form, when signed by you, the Parent of the Minor whose name is set forth below, signifies your consent, authorization and permission for your Minor child to enter, submit Entry Materials (as defined in the Official Rules), participate in the Promotion and, if selected or drawn as a Contest or Sweepstakes winner, to avoid being disqualified as a potential winner and prize-recipient, because of their status as a Minor. Of course, you and your Minor child are still required to comply with all of the terms and conditions that apply to the Promotion and a copy of the Official Rules is available to you at any time by sending the Sponsors a stamped, self-addressed, business-size envelope to: “Blizzard World of Warcraft Summer Movie Promotion” – Official Rules Request, c/o Blizzard Entertainment, P.O. By your inserting your name and signing below, together with the printed name and the email address that your Minor child will use to enter the Promotion (which we will use to match with this Consent), in addition to providing your consent, authorization and permission referred to above, you are also agreeing, for yourself and on behalf of your Minor child, that you have read, that you understand and that you agree to be bound by and comply with all of the terms and conditions and obligations described and set forth in the Official Rules. You are also granting your consent to the processing of such personal data necessary to match this consent with the entry of my Minor child until the Promotion is completed. If, for any reason, you are unwilling or unable to do so, it is your responsibility to ensure your Minor child does not enter or participate in the Promotion in any way because if you allow or condone your Minor child entering, you will be deemed to give us your consent and agreement as required by the terms of this Consent. You are also acknowledging that the Sponsors will rely upon this Consent in determining eligibility to enter and participate in the Promotion and to be awarded a prize if your Minor child is selected as a potential prize winner. You may also be required to accept the prize on behalf of your Minor child, if required by law or regulation.

You acknowledge, understand and agree that if any of the acknowledgments, representations and agreements described or made above are found to be untrue, false or misleading in any way, you may be liable, to the fullest extent of applicable law or regulation.
